About the Policy

We collect, store, process and use personal and sensitive data to be better able to serve our clients and candidates' needs. Personal data may be collected or used in order to sustain any of the following business practices:

- To provide specialized recruitment services to our candidates and clients, and expedite the entire process;
- To better answer your questions and enquiries;
- To improve our customer service & enhance the value of our services, in-person & digitally;
- To submit candidate details to our clients in order to apply for jobs or assess their fit for jobs;
- To enable our candidates to subscribe for job alerts via our newsletter, to keep them informed about jobs that may be of interest;
- To enable us to develop & market products and services, only where you have consented to be contacted for such purposes;
- To assess whether job openings we have may be a suitable fit for our candidates;
- To market our portfolio of recruitment services (full-time, part-time, international recruitment program, recruitment process outsourcing)

If You Don't Give Consent

If you do not want to give us consent to use your personal information in any of the ways noted above, notify the company representative you are assigned. From time to time we may reconfirm your desire to consent to our policy above, which you may still decline.
